

## Register of Pecuniary Interests

### Introduction and purpose

This register of pecuniary interests is published pursuant to section 54A of the Local Government Act 2002.

The Act requires Environment Southland (Council) to publish a summary of elected members' financial, business and personal interests including certain assets, business associations and gifts they have received annually.

The summaries are an individual snapshot of members' interests for the previous 12-month period, from **30 January 2024 to 28 February 2025**. They are updated annually.

The purpose of the register of pecuniary interests is to record elected members' interests, providing transparency and strengthening public trust and confidence in local government processes and decision-making.

### Pecuniary Interest Key

1. Company directorship and controlling interest (section 54E(1)(a));
2. Hold or control more than 10% of the voting rights in a company (section 54E(1)(a))
3. Other company or business entity (except as an investor in a managed investment scheme)
4. Employment (section 54E(1)(c))
5. Beneficial interests in and trusteeships of trusts (section 54E(1)(d))
6. Organisations and Trusts that obtain or are seeking to obtain funding or other assistance from Council (section 54E(1)(e))
7. Council Appointments (section 54E(1)(f))
8. Real Property (section 54E(1)(g))
9. Beneficiary of a trust that holds real property (but excluding a trust that is a unit trust you have already disclosed under question 5 or a trust that is a retirement scheme whose membership is open to the public) (section 54E(1)(h))
10. Overseas travel (section 54F(1)(a))
11. Gifts (section 54F(1)(b))
12. Payments for activities (section 54F(1)(c))
