Kia ora,

I have referred the application/affidavit and memoranda to Judge Reid who directs:

Counsel for the Southland Regional Council has filed an application for stay, affidavit and memorandum of counsel. The memorandum seeks directions for parties to advise the court on their position by 9 December 2024 and then set for hearing. Counsel for Forest and Bird subsequently filed a memorandum advising that it opposes the application and seeking that Rule 7.17 District Court Rules applies with 10 working days to file any opposition. Taking into account NZ Forest and Birds proposed opposition and the impending holiday period I direct;

1. **By 18 December 2024:**
 - a. Parties are to advise the Court whether they support or oppose the Application, or are neutral, and whether they wish to be heard; and
 - b. Parties wishing to be heard in support of the application are to file a memorandum setting out their position and any supporting affidavits, and
 - c. Parties wishing to be heard in opposition to the application are to file a notice of opposition with any supporting affidavits.
2. Those parties who have indicated they wish to be heard are to file a joint memorandum with a proposed hearing timetable, availability and proposed location for hearing by **24 January 2025**.
