## MAY IT PLEASE THE COURT

- This memorandum of counsel is filed on behalf of Waihopai Rūnaka, Hokonui Rūnaka, Te Rūnanga o Awarua, Te Rūnanga o Oraka Aparima, and Te Rūnanga o Ngāi Tahu (collectively Ngā Rūnanga).
- 2. In the minute of the Environment Court (19 October 2021),¹ the Court directed that (our **emphasis**):

To assist with the preparation of the conference agendas, the planning witnesses will identify the issues on which they require technical advice to inform their opinion on the wording of the plan's provisions. Secondly, the planners are to observe any technical conference relevant to the matters in relation to which they are giving evidence. They may observe via AVL or in person.

- Counsel understands that, following the planning experts raising an issue about attendance at other expert conferences as observers, the Commissioner confirmed the Court's direction.
- 4. On the basis of the Court's direction, Ms Davidson, planning witness for Ngā Rūnanga, is expected to attend the following conferences as an observer:
  - (a) Farm systems Monday 22 November and Monday 6 December 2021;
  - (b) Science/water quality Wednesday 24 November to Friday 26 November, and Friday 3 December 2021; and
  - (c) Ecology Wednesday 1 December 2021.
- 5. Unfortunately, Ms Davidson is unavailable to observe the entirety of those conferences, due to pre-existing commitments. Leave is respectfully sought for Ms Davidson not to attend the following sessions:
  - (a) Science/water quality Afternoon of Wednesday 24 November 2021 and the morning<sup>2</sup> of Friday 26 November; and

- (b) Farm systems Monday 6 December 2021 for either part of, or the full day.
